
To be able to run the affairs of the organization, your PLAREB Board of Directors (BOD) meet every 1st Thursday of the month to discuss activities like the GMM, offerings of Continuing Professional Development (CPD) seminars not only to equip Real Estate Practitioners with updates in the industry, refresh skills and knowledge, address license renewal requirements, but also to serve as source of funds to manage the operations of the organization. The Board also discusses attendance to meetings outside of PLAREB, ways to improve the benefits of members, and concerns of the general membership.

For the information of members, the following Board Resolutions were approved starting the 2nd Quarter of the year:

To encourage early arrival of members during GMMs, the Board resolved to have a cut-off time of 2:30 p.m. to be counted an official meeting attendee. Much is lost when a member comes in late or does not attend GMMs at all. Attendance also shows support to the Board, the guest speakers, presenters, and co-brokers.

Other Board Resolutions include: (a) the allotment of funds for the procurement of PLAREB T-shirt uniform for sale to members; (b) cancellation of the current DNS server provider to find a better one at a lower price; (c) approving the composition of PLAREB Comelec Members for the election of new directors for 2019; (d) approval of the rules and regulations for implementation during the whole election process starting from nomination day until 40 days after the election period; (e) allotment of funds for sponsorship in PAREB National Convention (NATCON); (f) allotment of funds for the services of a choreographer for PLAREB dance contest in NATCON; (g) allotment of funds for PLAREB Anniversary celebration in October 2018; and (h) advance payment for PLAREB Christmas Party. Board Resolutions are prepared when fund allocation is required for projects or activities, and other disbursements that are not recurring expenses.
