Glimpse of the GMM Campaign Against "Kolorum" By: Zyzylyn Ong Salcedo



Kolorum - walang permiso o hindi nakarehistrong negosyo. This is one of the challenges legit brokers like us face in our work. And it is timely that last April 2022, the Joint Memorandum Circular on the formation of an Anti-illegal Real Estate Practices Interagency task force took effect.

To talk more about this, Atty Jann Roby Otero (DHSUD 4A regional director) and Atty. Norman Francisco Doral (director of DHSUD NCR) were invited to our GMM to discuss the campaign against colorum of developers, brokers, and sales persons.

This JMC came about due to the prevalence of illegal real estate transactions and proliferation of unregistered real estate service sellers and developers for the protection of real estate buyers. it aims to implement comprehensive program at the local and national level.

National, regional, and local task forces are tasked to oversees the implementation of the program, ensures public awareness, develop capacity building actions, plans, programs, and projects, and assist actual and potential victims from malpractice.

Questions about how to go about the implementation were raised and a separate seminar for this was requested by PP Beth Zepeda. She also pointed that while we have the JMC, we need the IRR for the guidelines to implement. But we do understand that since the task force was just launched June 2022, they are still in transition and it may take a while to roll down to the local levels.

PP Guia suggested a national information campaign followed by a city ordinance by the LGUs and down to the barangay level. Another comment made by Thess Gabuat asking why BIR is not included in the member agencies under the JMC, was duly noted.

SEC. 4 OF P.D. 957 REGISTRATION OF PROJECTS


